self employed individuals tax center internal revenue service May 28 2022 if your expenses are less than your income the difference is net profit and becomes part of your income on page 1 of form 1040 or 1040 sr if your expenses are more than your income the difference is a net loss you usually can deduct your loss from gross income on page 1 of form 1040 or 1040 sr but in some situations your loss is limited
