Based on decades of scholarship, documentation newly available from the opening of Soviet archives, declassification of Western intelligence service records, as well as diaries and reports written in the camps, Cesarani provides a sweeping reappraisal that challenges accepted explanations for the anti-Jewish politics of Nazi Germany and the inevitability of the "final solution." The persecution of the Jews, as Cesarani sees it, was not always the Nazis' central preoccupation, nor was it inevitable. He shows how, in German-occupied countries, it unfolded erratically, often due to local initiatives. For Cesarani, war was critical to the Jewish fate. Military failure denied the Germans opportunities to expel Jews into a distant territory and created a crisis of resources that led to the starvation of the ghettos and intensified anti-Jewish measures. Looking at the historical record, he disputes the iconic role of railways and deportation trains. From prisoner diaries, he exposes the extent of sexual violence and abuse of Jewish women and follows the journey of some Jewish prisoners to displaced persons camps. David Cesarani's Final Solution is the new standard chronicle of the fate of a heroic people caught in the hell that was Hitler's Germany.

Nazi Policy, Jewish Workers, German Killers Dec 29 2019 This volume uses new evidence to shed light on controversial issues in current Holocaust scholarship.

The Death Marches Feb 08 2021 Blatman writes about the end phase of the German concentration camp system when the Nazis, realizing that they were losing the war, were faced with the enormous problem of what to do with the people being held captive. As these camps were being evacuated, the collapse of the front in Poland and the advance of the Red Army generated frantic waves of flight and the evacuation of millions of civilians and soldiers. The panicky retreat created conditions under which prisoners were murdered in horrific death marches. Gas chambers in faraway camps were no longer in use, and now the slaughters took place on the very doorsteps of ordinary German civilians' homes and in the streets German and Austrian towns. Unknown numbers of ordinary civilians across the dissolving Reich, fearing for the fate of their families and property, participated in the lethal eruption of violence. The book is divided into two sections. The first part provides an detailed

overview of the camp system and a thorough chronological treatment of the camp evacuations during the winter of 1944-45 and the spring of 1945. The second part is a case study of the atrocity in the German town of Gardelegen where over 1000 prisoners were murdered, along with about 400 in the surrounding villages. This event serves as a focused example of the breakdown of the evacuation plans at the end of the war.

The Last Nazis Jan 28 2020 The history of the shadowy Werewolf guerrilla bands formed at end of the Second World War as the last desperate defence of Nazis. Founded by Heinrich Himmler in 1944 when it became clear Germany would be invaded, the Werewolf guerrilla movement was given the task of slowing down the Allied advance to allow time for the success of negotiations or wonder weapons. Staying behind in territory occupied by the Allies, its mission was to carry out acts of sabotage, arson and assassination, both of enemy troops and of defeatist Germans. Perry Biddiscombe has researched the movement exhaustively, and details Werewolf operations against the British, Russians and fellow Germans, on the Eastern and Western Fronts and in the post-war chaos of Berlin. Giving the lie to the established story of a cowed German population meekly submitting to defeat, this is a fascinating insight into what has been described as the death scream of the Nazi regime.

The Nazis' Last Victims Jun 14 2021 The Nazis' Last Victims articulates and historically scrutinizes both the uniqueness and the universality of the Holocaust in Hungary, a topic often minimized in general works on the Holocaust. They came at the invitation of Reinhard Heydrich and were almost all high-ranking Nazi Party, government, and SS officials. The exquisite position by the lake, the imposing driveway up to the villa, culminating in a generously sized roundabout in front of the house, the expansive, carefully landscaped park, the generous suite of rooms that opened on to the park and the lake, the three-level terrace that stretched the entire garden side of the house, and the winter garden with its marble fountain, all give today's visitor to the villa a good idea of its owner's aspiration to build a sophisticated, almost palatial structure as a testament to his cultivation and worldly success. But the beauty of the situation stood in stark contrast to the purpose of the meeting to which the fifteen had come in January 1942: the 'Final Solution of the Jewish Question'. According to the surviving records of the meeting, items on the agenda included the precise definition of exactly which group of people was to be affected, followed by a discussion of how upwards of eleven million people were to be deported and subjected to the toughest form of forced labour, and following on from this a discussion of how the survivors of this forced labour as well as those not capable of it were ultimately to be killed. The next item on the agenda was breakfast.
